DUI 3 rd OFFENSE (.15 BAC or greater) Class IIIA Felony		<ul style="list-style-type: none"> ● 60 days in jail and required use of a continuous alcohol monitoring device for no less than 60 days after release ● \$1,000 fine + court costs ● 5- to 15-year license revocation ● No driving for 45 days ● <i>Shall order interlock</i> 	<ul style="list-style-type: none"> ● 180 days to 5 years in jail ● Up to \$10,000 fine + court costs ● 15-year license revocation
